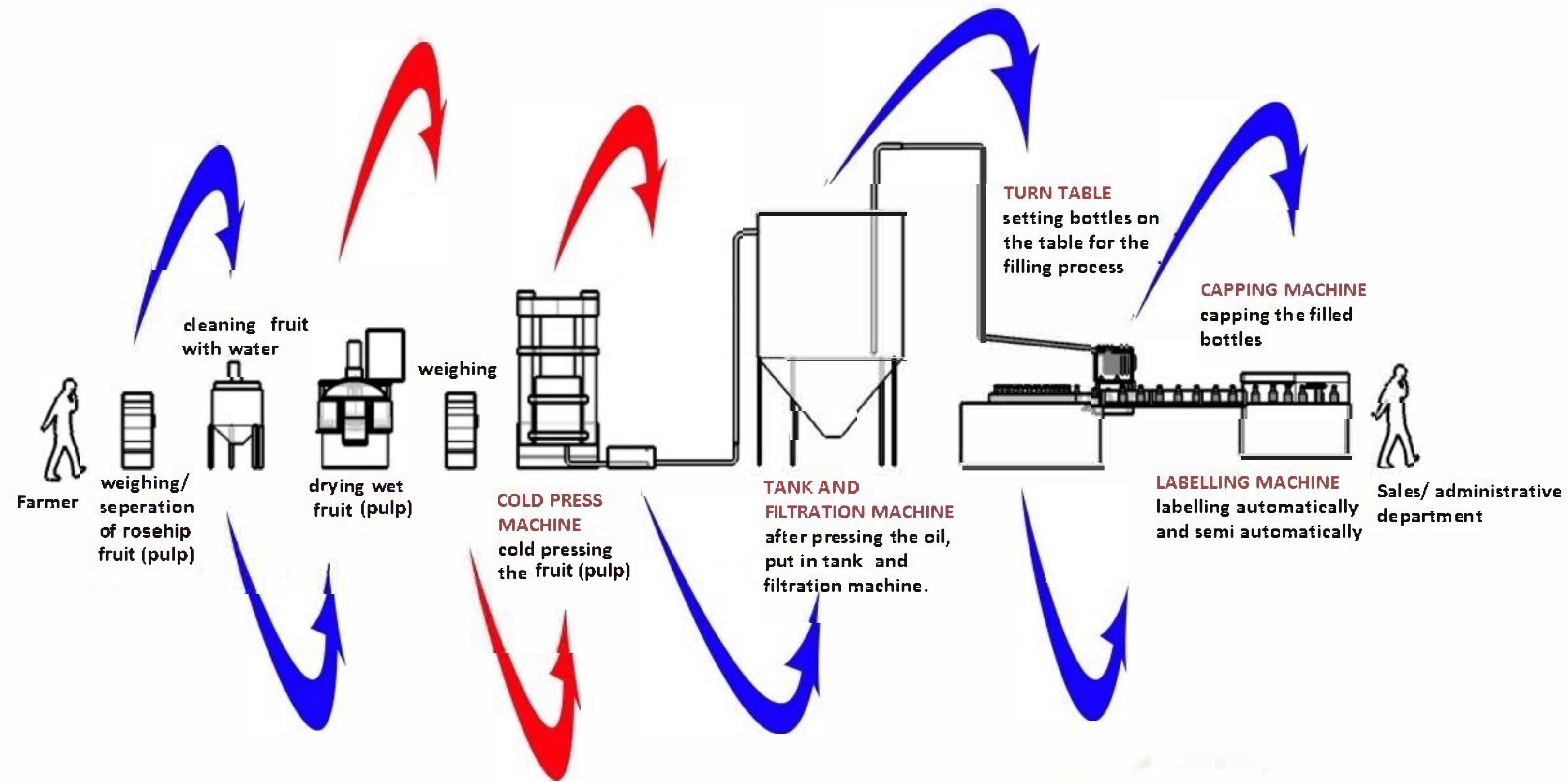

3. COMPOSITION/INFORMATION ON INGREDIENTS

Chemical Composition: Cold pressed Rosehip Oil is a vegetable oil derived from the pulp of Rosa canina.

The product does not belong to any list of substances supposedly hazardous to human or animal health according to EU guideline 548/67 and further amendments, nor to those having recognised exposition limits.

4. FIRST AID MEASURES

Skin Contact: No adverse effects are expected due to its use in personal care products. If irritation occurs, wash area with soap and water. If irritation persists, seek medical advice.

Eye Contact: Irrigate with heavy stream of water for at least 15 minutes or until irritation subsides. Get medical attention if irritation persists.

Inhalation: No adverse effects due to inhalation of vapors are expected at ambient temperatures.

Ingestion: It is a common food ingredient.
